"INDIAN CONCRETE INSTITUTE – KBC" Annual General Body Meeting for year 2014

ICI-KBC, Annual General Body Meeting (AGM 2014) of Indian Concrete Institute, Karnataka Bangalore Centre, held on **Saturday, 12th-July-2014, 06.30PM** at **Maharaja hall,** Bangalore City Institute, **Chamarajpet, Bangalore-4.**

- Welcome: <u>Dr. R. Nagendra</u>, Chairman, ICI-KBC welcomed the members. He briefly outlined the activities of the centre and thanked all the members for their cooperation. He emphasized the need to update the member's data base, and sought the cooperation of all the members. He has also explained how the ICI-KBC is trying to reach Industry / students and others in training on cement, concrete, admixtures etc.
- 2 Reading and recording the minutes of AGM 2013: Secretary, Ms Sapna Devendra, read out the minutes. Mr. Rajkumar Pillai proposed that the minutes be recorded, as followed by Ex-Officio Members. Mr. N.R. Ashok seconded. The AGM approved the recording of minutes of AGM 2013 unanimously.
- 3 Highlighting the activities of ICI-KBC for year 2013-14 by a power point presentation. Later the secretary sought the approval of AGM-2014
- 4 Presentation of the Annual Report for the year 2013-2014: **Ms. Sapna Devendra**, Secretary presented the audited statement of accounts. **Mr. D. Sitaramaiah** proposed that audited statement of accounts be accepted. **Dr. V. Ramachandra** seconded. The AGM unanimously accepted the Accounts.
- 5 Appointment of auditors for the year 2014-15: <u>Mr. L.R. Manjunatha</u> Proposed the continuation of the auditors M/s. Venkatachala Raghavendra & Company and <u>Mr. Jagadish Vengala</u> seconded.

6 Under any other points:

- a. Bulk SMS registration to reach maximum ICI members and other professionals, <u>was done</u> <u>during the year 2013-14.</u>
- b. Service tax registration was done during September 2013, ICI-KBC has paid the same for last 6 months, which is included in audit report 2013-14.
- c. Mr. D. Sitaramaiah enquired about the active functioning of ICI student chapters and suggested to have three/four meetings every year. ICI secretary Ms. Sapna Devendra replied ICI-KBC conducted one event in all student chapters and accepted the suggestion to improve it further. She added few ICI student chapters voluntarily come forward for renewal of membership, Mr. D. Sitaramaiah insisted ICI-KBC to invite office bearers of ICI student chapter

to attend ICI-KBC meetings. Ms. Sapna Devendra agreed to this point Dr. Radhakrishna concluded providing information on ICI-KBC plan to have annual convention for all student chapters under one roof.

d. Dr. Aswath M.U insisted to have one individual industry expert to coordinate activities of each student chapter along with the faculty of the respective institution. Mr. D. Sitaramaiah insisted to have clarity on the role of industry expert as a mentor.

After the presentation of annual report of 2013-14 by ICI-KBC secretary Ms. Sapna Devendra. Mr. D. Sitaramaiah sought clarification of an item "TDS-2 lakhs" under the heading of current assets – whether TDS is refundable? Are we filing returns to claim the exemption under 15H.? Mr. L.R. Manjunatha, Vice chairman ICI-KBC, clarified the TDS matter is handled by head office and exemptions are claimed. The refund money will not come to ICI-KBC Ms. Sapna Devendra added summing up above discussion that ICI-KBC now registered for service tax in Karnataka Bangalore centre.

For a query from <u>Dr. V. Ramachandra</u> on fixed deposit renewal & receivables from M/s. "Schwing stetter, Reliance etc looks like" a copy and paste of previous year statement, Mr. L.R. Manjunatha and Ms. Sapna Devendra clarified and convinced in reference to 2013-14 annual report.

Mr. D. Sitaramaiah wanted to know the status of some funds ICI-KBC owes to M/s. BASF India Limited, Ms. Sapna Clarified the same transferred to the other ICI centre.

Dr. V. Ramachandra during his brief talk on ICI activities and initiatives (H.O) the following points highlighted.

- 1. Request from foreign nationals to become members of ICI.
- 2. Setting up-of ICI chapters in two countries.
- 3. All India students fest on concrete.
- 4. Internship for students Mr. Rajkumar Pillai.
- 5. M/s. Ultratech plan to have one full day program with mix design training in all student chapter affiliated to ICI (one event per centre yearly).
- 6. Birds eyes view on various committees, codes, hand book publications status from ICI H.O new initiatives.
