

#### Waterproofing of Structures:

Waterproofing of Structures: Waterproofing of concrete structures is done by either suitable extraneous treatments like applying paints, fixing bitumen felts etc. or internally by suitable design of the concrete mix, addition of suitable admixtures in the concrete or mortar at the time of mixing and/or installing water bars at the joints. The design, material and workmanship should conform to the relevant standard codes where applicable.

Waterproofing is the formation of an impervious barrier over surfaces of foundations, roofs, walls, and other structural members. The function of the impermeable barrier is to prevent water penetrations. The building surfaces are made water-resistant and sometimes waterproof. The utilization of liquid waterproofing membrane, cementitious materials, polyurethane liquid membrane, and bituminous material are common in the waterproofing of buildings. Waterproofing is necessary for the basement, walls, bathrooms, kitchen, balconies, decks, terrace or roofs, green roofs, water tanks, and swimming pools, etc. In line with this continuing endeavour, ICI-Bengaluru Centre is organising a one-day national seminar titled
